Sub: Requirement of Coaches.

Recently Railway Board had decided for conversion of 12367 / 12368 Bhagalpur – Anand Vihar Vikramshila Express and 12321/12322 HWH CST Mumbai Mail from ICF to LHB rakes. For conversion of these 02 trains some coaches were sent to Eastern Railway, but subsequently taken for use in CR, ECR and NFR. Allotment and present availability for these conversions are as under:

It was also planned by Board to make good shortage of conventional ICF coaches, mainly GSCN, GS and SLR coaches with conversion of the above mentioned 02 trains. However, considering the low rate of transfer of the allotted coaches to Eastern Railway these conversions are not likely to fructify in the near future. Acute shortage of ICF coach would continue unless process of supply of LHB coaches to Eastern Railway is expedited or ICF coaches are transferred for day to day requirement and augmentation. Net requirement of various types of ICF coaches is given below.
