In reference to your letter quoted above, the RTI request has been examined and as per available records, comments pertaining to coaching are as under:-

Train no. 14332 KLK-DLI Express previously running as passenger train no. (54304 KLK-DLI) via UMB-SRE-MTC routs. During Time Tabling exercise train have been converted into express train and running on its existing route via UMB-SRE-MTC.

Similarly train no. 14331 DLI-KLK was also running as passenger train no. (54303 DLI-KLK) via PNP-UMB routes.

Both trains (54304/54303) running on different routes since last 20 years.
