NOTE

- 1) T. No. 16729/30 (PUU-MDU-PUU) will continue to byepass NCJ, skipping stoppage at NCJ and will have additional stoppage at NJT for a period of 90 days until yard remodeling works are completed.
- 2) Freight: Restriction for inward loads to NCJ goods shed may be planned.

As instructed by AGM/SR, during execution of LB/PB exceeding 06 hours, one SAG officer from HQtrs of concerned department and ADRM of the Division to visit the worksite prior to the commencement of the blocks to ensure preparedness and availability of adequate manpower and machines including availability of stand-by crane for all bridge/LUS works and to be available there during the execution.

Railway Board has advised that the division shall ensure site preparedness and adequate resources in terms of materials & manpower so that there is no bursting of block and timeline. Board's instructions with regard to availability of officers at the site may be ensured. Division should take all necessary steps & precautions to ensure safe running of trains during execution of the work with minimum detention to trains.

The following may please be ensured:

- Blocks to be given in a corridor in the same section so that trains are not detained in subsequent blocks.
- Timely supply empties for the days loading to be ensured and interchange empties not to be regulated on account of blocks. Movement and placement of inward loads to be ensured.
- Where feasible, temporary single line working to be introduced for running freight trains.
- The detention to freight trains may be recorded and sent in daily position.
- Active steps to be taken to maintain TSR within the permitted limit.
- All precautions to be taken to avoid block burst and punctuality loss to trains.
- In case of change in pattern of train services, blocks shall be rescheduled suitably without affecting punctuality.

Wide publicity to be given through Press, Media, Station Notice Boards and Public Address system regarding late-running/diversion/cancellation of trains
